When I exited my vehicle outside the scene, I observed Reese Mitchell outside with a laceration to her head possibly from the knife. She said "my mom just stabbed me and my dead". I told her stay outside and entered the home. Once I entered the home, I observed Officer Pruitt and Officer Ramirez were trying to take control of J. Mitchell's hands which had a knife. She was actively resisting the officers. I observed the knife on her right hand. Officers were able to release the knife from her hand which fell on the kitchen counter and slid on the floor in the kitchen. It was a large kitchen knife. J. 
