Mr. Watts is serving his 1st Incarceration in Wisconsin as a new admit. He is here as an ICC case, serving a Colorado sentence. He is not serving a Wisconsin sentence.

**18CR2003 District Court, Weld County, Colorado: 3 counts - Murder 1-After Deliberation; 2 counts - Murder 1 - Victim under 12/POS of Trust; Pregnancy-Unlaw Term-1st Deg/Woman; 3 counts - Tampering w/Deceased Human Body**

Mr. Watts was sentenced on 11/19/18 to 5 Life Sentences without Parole; 48 years in Prison; 3 - 12 year sentences. Per information provided by Colorado DOC including the Warrantless Arrest Affidavit, on 08/13/18 officers received a call in regards to completing a wellness check on S.W. S.W. was said to be 15 weeks pregnant and had not been feeling well. The caller was concerned because she had not heard from her and could not locate her. When the officer arrived, a search of the house was conducted and S.W. and her two children were not there. Mr. Watts stated that earlier that morning he had told her he wanted a marital separation. He stated they were not arguing but were emotional. He had then left for work. All of S.W.'s personal effects were in the house. When S.W. and the girls hadn't returned by 08/14/18 a press release was issued. During the two-day investigation it was revealed that Mr. Watt's was having an affair. He told police that after telling S.W. that he wanted a separation he observed one of their daughter's sprawled out on their bed and S.W. actively strangling the other daughter. Mr. Watts told detectives he went into a rage and strangled S.W. He then loaded all three bodies into the back seat of his work truck and took them to an oil field. Mr Watts told detectives he buried S.W. near two oil tanks and he dumped his two daughter's bodies inside of the oil tanks. He identified the area for the detectives on an aerial photograph.

**Motivation:** *He states, "honestly, I am still trying to piece it all together myself." He is trying to distance himself as much as he can right now from that moment. He states in the last week or so before this happened, they never really slept in the same room or talked much. Arguing about their relationship and it all came to a head. A lot of things were said that they didn't mean to each other.*

**Current Attitude:** *He is not currently appealing the case. He has been told to appeal it but is not in the right state of mind to do this right now. He doesn't want to make people go through that process for just 2-3 years. He just wants to start the healing process right now if that is even possible for him. In regards to his feelings towards the victims, he just kind of renewed his faith and talks to the victims through prayer. The victims are his family.*

## Staffing Comments

*This review was conducted pursuant to WI Administrative Code 302, and addresses custody, site placement and program assignments.*

**Maximum custody at DCI is recommended.** This recommendation takes into account the dynamics of the current offense and sentence structure. Mr. Watts is an ICC Inmate from Colorado. Colorado information indicates he was not a conduct issue in the county jail or in the prison. He has had no conduct reports thus far at DCI. When discussing his current offense with Mr. Watts he showed emotion at the mention of his victims and appears to still be processing the crime. He was encouraged to talk with PSU. Based on his positive conduct, stable work history and DCI security approval he will be recommended to stay GP at DCI.

12 month recall as no substantial changes are anticipated before this. Field information was available.
