



One is a current student and the other is a home-schooled student. Frost was a teacher at Crenshaw Christian Academy. Frost sent an obscene photo and asked that the student send a photo from the abs down. Both sent photos back and forth. This continued for approximately 2 weeks.

Frost initiated talk of meeting for sex. The male students each said that they knew of a place they could met. Frost met one student A. P (16 years old) in Crenshaw County. She met the other student G T (15 years old) in Pike County multiple times. Frost confessed to having sex with these two students.

Frost sent obscene photos by phone. She also traveled from her home to another county to engage in sex with a 15 year old. The 15 year old is her student.

She also sent obscene photos to a 16 year old that is a student and was her former student.

On this date, Inv. Powell met with Crenshaw County DHR and Mrs. Becca Baggett from the Crenshaw Christian Academy regarding an inappropriate photo that was shared amongst some of the student body. The teacher was a math teacher by the name of Crystal Frost and stated that an anonymous call came into the school stating (GT) had a nude breast photo of the teacher on his phone. After chapel on Wednesday 8/23/2023 a student (CL) came forward telling her it was true. Mrs. Baggett confronted the teacher (Crystal Frost) at which time the teacher admitted to a different photo she sent to the cheerleaders where she pulled her "Nike" shorts up high allowing her butt cheeks to show, took the picture and sent it as a joke. Mrs. Baggett stated that due to the admittance of inappropriate behavior she could resign or be terminated. Mrs. Baggett did accept the resignation and she cleaned out her office Thursday. From this point a call was made to (CL) and parents asking the juvenile to come in and make a statement, at which time the juvenile did come shortly after and stated that the photo was on (GT) phone and he showed it to him, with an additional statement that (GT) had sex with the teacher in the vehicle. A call was placed to the parents of the juvenile (GT) and asked about an appropriate interview time and consent search of the phone for evidence. A time was set up later in the evening after the football game this date of Friday night. At which time more could be explained and a search warrant was written as well for the defendant's phone. Interview was concluded and an I/O Incident-Offense report written for a case number and initial report. Investigation is still ongoing.

On this date, Chief Johnson and Inv. Powell went to a residence in Pike County to interview (GT) a juvenile. The juvenile stated to these officers that when he was at the beach on his phone chatting and snapping, Crystal Frost sent him an upper shoulder picture that was normal, which he replied "I can't see it?" so then she sent him a breast nudity picture thru Snap Chat. This continued for approximately a week or two to the point sex was offered and (GT) stated he knew a place that they could go. (GT) stated that he deleted the contacts and texts from his phone to include all nudity from her and when sex occurred it was on a piece of land near or belonging to his family in which he dropped a PIN for her to locate, which is in Pike County. The sex occurred 4-5 times always in the same location, nothing ever happened at school. She would travel to meet him and only once did it happen at night in a vehicle and she performed oral sex on him which was when he went to feed the dogs, normal for his routine chores at night. These interactions stopped approximately a month and a half ago, with (GT) stopping it, knowing if he did not it would have continued. (JL),(AP),(KP) and (JB) are others stated to have pictures, yet (GT) did not believe any other student had sex with Crystal Frost as far as he knew at this time. Interview was concluded and phone was returned.

On this date, Inv. Powell and Chief Johnson interviewed (AP) a juvenile, in reference to information about a former teacher Crystal Frost and Snap Chat conversations that may have led to sexual contact. AP stated to these officers that he was a student at CCA (Crenshaw Christian Academy) last year and has been home schooled since the start of this year. Initial contact was about a month ago with a nude breast photo, with coercion of a picture leading up to asking if the child knew of a place to have sex. The place that sex was had was in the city limits of Luverne in Crenshaw County of Mt. Ida Rd. on a farm known to the victim. The victim stated that oral sex was performed and then direct intercourse. The teacher made no conversations with him from arrival to ending of the sexual contact and later only sent 2 more pictures and then blocked him totally from Snap Chat. The act only took place one time starting from last month in July from sent media pictures and no contact any further after the blocked contact of Mrs. Frost to the victim after inquiry.

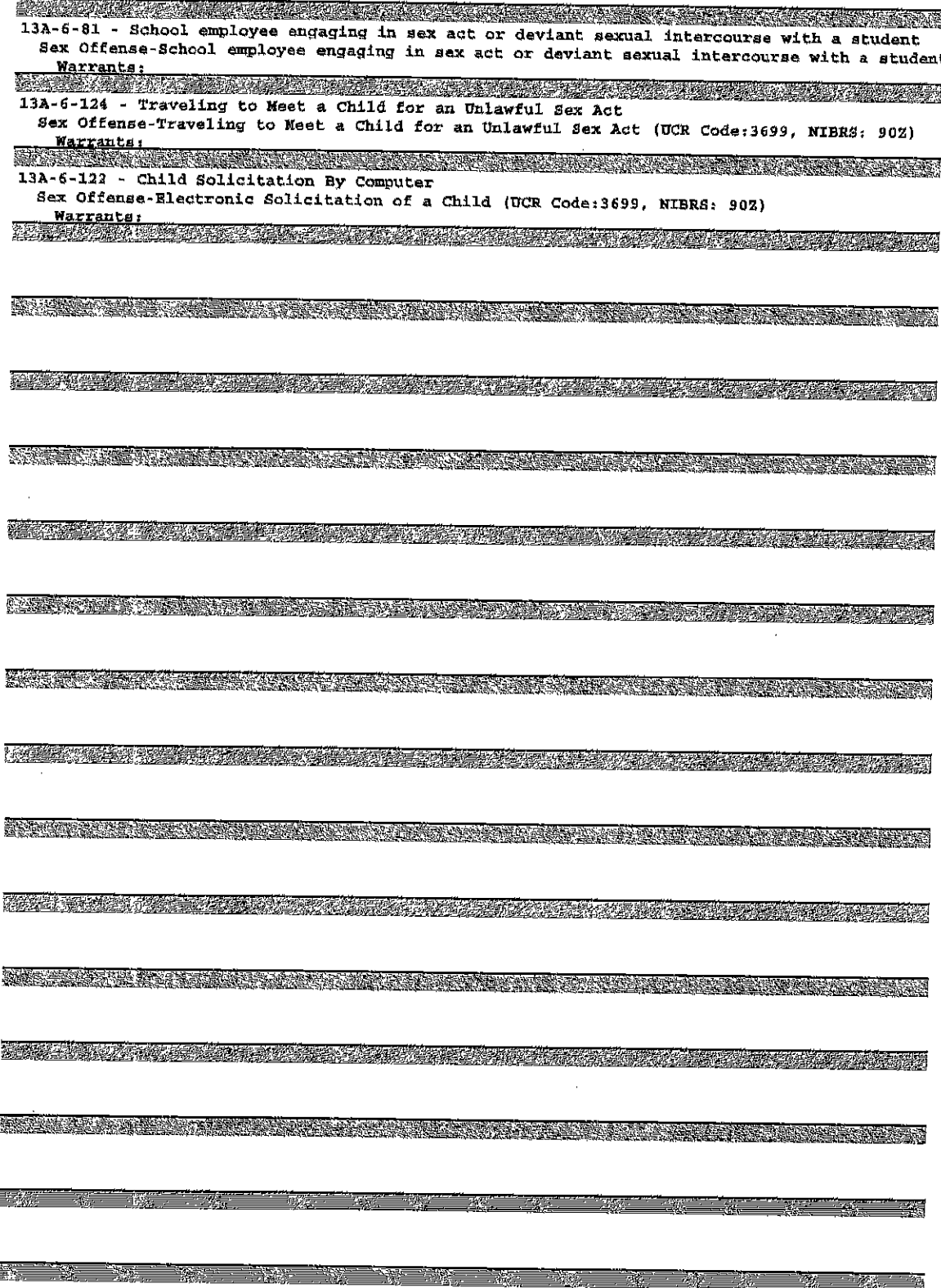
