Comes now Donald R Cobb, Prosecuting Attorney within and for Scott County, Missouri, being duly sworn upon oath and upon information and belief, and states that there is probable cause to believe that the accused, acting alone or in association with another, committed the following crimes:

**COUNT: I**

In violation of Section 566.086, RSMo, committed the class E felony of sexual contact with a student, punishable upon conviction under Sections 558.011 and 558.002, RSMo, in that between March 1, 2023 and May 31, 2023, in the County of Scott, State of Missouri, the defendant was an employee of [REDACTED], and performed oral sex on Victim 1 in a classroom.

**COUNT: II**

In violation of Section 566.086, RSMo, committed the class E felony of sexual contact with a student, punishable upon conviction under Sections 558.011 and 558.002, RSMo, in that between March 1, 2023 and May 31, 2023, in the County of Scott, State of Missouri, the defendant was an employee of [REDACTED] and engaged in sexual intercourse with Victim 1 at the victim's home.

Class A felony - a term of years not less than ten years and not to exceed thirty years, or life imprisonment;

Class B felony - a term of years not less than five years and not to exceed fifteen years;

Class C felony - a term of years not to exceed three to ten years and/or a fine not to exceed ten thousand dollars;

Class D felony - a term of years not to exceed seven years and/or a fine not to exceed ten thousand dollars;

Class E felony - a term of years not to exceed four years and/or a fine not to exceed ten thousand dollars.
