I TOOK OVER THE INVESTIGATION AND WENT TO THE VICTIMS RESIDENCE. AT THE VICTIMS RESIDENCE, AND WITH THE MOTHERS CONSENT, THE VICTIM GAVE ME ACCESS TO HER CELL PHONE AND GAVE ME CONSENT TO ASSUME ONLINE PRESENCE AND USE OF THE CELL PHONE (FORM FILLED AND SIGNED BY ALL PARTIES) PENDING THE INVESTIGATION.
