THE VICTIM, GABRIEL ALEXANDER NIETO, STATED THAT HE MET THE SUBJECT ON THE TINDER DATING APP ON NOVEMBER 16, 2023, AND HE MET AND PICKED UP THE SUBJECT, WHO HE KNOWS AS TINY FROM HER TINDER ACCOUNT, THAT SAME DAY AT THE HOLIDAY INN EXPRESS & SUITES, LOCATED AT 11520 N. KENDALL DRIVE. THE VICTIM STATED THAT HE DROVE THE SUBJECT TO AN AREA ON SW 8TH STREET WHERE THEY PURCHASED AND SMOKED MARIJUANA. THE VICTIM STATED THAT HE THEN DROPPED THE SUBJECT BACK OFF AT THE HOLIDAY INN AFTERWARDS, CLAIMING THAT HE HAD NO SEXUAL RELATIONSHIP OR ACTIVITY WITH THE SUBJECT. THE VICTIM FURTHER STATED THAT ON SATURDAY, NOVEMBER 25, 2023, AT APPROXIMATELY 05:00 HOURS, HE RECEIVED A MESSAGE FROM TINY ON HIS TENDER APP, AGAIN REQUESTING HIM TO MEET HER AT THE HOLIDAY INN EXPRESS & SUITES. THE VICTIM STATED THAT HE AGREED TO THE MEETING, AND AGAIN RESPONDED TO THE HOLIDAY INN EXPRESS & SUITES, LOCATED AT 11520 N. KENDALL DRIVE. THIS TIME HOWEVER, THE VICTIM STATED THAT THE SUBJECT APPROACHED FROM A BLACK AND WHITE CHEVROLET EQUINOX PARKED ON THE WEST SIDE OF THE HOTEL IN A NEIGHBORING PARKING LOT, AND SHE APPROACHED HIS 2019 CHRYSLER 300. THE SUBJECT WAS CARRYING A 1-GALLON ZEPHYRHILLS WATER JUG IN HER LEFT HAND AND OPENING THE FRONT PASSENGER DOOR OF THE VICTIMS VEHICLE. THE SUBJECT REMAINED OUTSIDE THE VEHICLE HANGING IN THE FRONT PASSENGER SIDE DOOR AND TOLD THE VICTIM THAT SHE NEEDED MONEY TO FIX HER VEHICLE. THE VICTIM STATED THAT HE DID NOT APPRECIATE THE SUBJECT TELLING HIM TO MEET HER THERE WITHOUT DISCLOSING THE FACT THAT SHE ONLY WANTED MONEY BUT SAID THAT HE OFFERED HER THE \$60 CASH HE HAD ON HIM TO HELP HER ANYWAY. THE VICTIM THEN STATED THAT THE SUBJECTS DEMEANOR CHANGED RAPIDLY, AND SHE YELLED YOU GUYS ARE OUT TO GET ME!. THE VICTIM THEN STATED THAT THE SUBJECT BEGAN TO POUR TO CONTENTS OF THE 1-GALLON JUG ONTO THE FRONT PASSENGER SEAT OF HIS VEHICLE. WHICH HE DESCRIBED AS BEING YELLOW IN COLOR AND SMELLING LIKE WHAT HE BELIEVED TO BE GASOLINE. THE VICTIM ATTEMPTED TO PUSH THE JUG OUT OF HIS VEHICLE CAUSING ADDITIONAL IGNITABLE FLUID TO SPILL INSIDE HIS VEHICLE ON THE SUBJECT AND HIS RIGHT SIDE, AT WHICH POINT THE SUBJECT PRODUCED A CIGARETTE LIGHTER IN HER RIGHT HAND, AND IGNITED THE FLUID, SETTING FIRE TO THE INTERIOR OF THE VICTIMS VEHICLE, THE VICTIMS RIGHT ARM, AND THE SUBJECT HERSELF. THE VICTIM STATED THAT HE IMMEDIATELY JUMPED OUT OF THE DRIVER DOOR OF HIS VEHICLE AND BEGAN ROLLING ON THE ASPHALT TO EXTINGUISH THE FLAMES ON HIS BODY, WHILE HIS VEHICLE WAS SOON FULLY ENGULFED IN FLAMES. THE VICTIM THEN STATED THAT HE PRODUCED A FIREARM FROM HIS RIGHT WAISTBAND AND POINTED IT AT THE SUBJECT FEARING THAT SHE WOULD MAKE FURTHER ATTEMPTS TO LIGHT HIM ON FIRE. HOWEVER, THE VICTIM STATED THAT THE SUBJECT FLED THE SCENE ON FOOT AND WHEN HE DETERMINED THAT SHE WAS NO LONGER A THREAT. HE PUT HIS GUN BACK INTO HIS WAISTBAND AND WENT INSIDE THE HOTEL WHERE HE ASKED THE FRONT DESK TO CALL HIM AN AMBULANCE AND A FIRE TRUCK DUE TO HE AND HIS VEHICLE BEING SET ON FIRE. THE VICTIM WAS SHOWN A LIN-UP AND POSITIVELY IDENTIFIED THE SUBJECT AS DESTINY LENAI JOHNSON. WHILE INVESTIGATING THE SCENE, AND ADDITIONAL CALL WAS RECEIVED ON SATURDAY,...
