On October 05, 2023, the Montgomery County Police Special Victims Investigations Division began an investigation into the sexual abuse allegations of a now adult male victim by a Montgomery County Public Schools teacher MELISSA MARIE CURTIS (DOB: 07/13/1992).

The incidents occurred for several months until the end of April 2015 at several locations to include inside a Montgomery County, Maryland public school, inside her vehicle while in Montgomery County, Maryland, and at residences in Montgomery County, Maryland.

The victim is known to your affiant and referred to as Victim A from this point forward.

At the time of the offenses, MELISSA MARIE CURTIS was 22 years old, and Victim A was 14 years old.

Victim A was enrolled in eighth grade at the same Montgomery County Public School where MELISSA MARIE CURTIS was employed as a teacher.

On October 05, 2023, Victim A was interviewed at the Special Victims Investigations Division in Rockville, Maryland.

Victim A disclosed when he was in the eighth grade; MELISSA MARIE CURTIS touched his penis with her hand over top of his clothing while in a Montgomery County Public Schools classroom. Victim A stated MELISSA MARIE CURTIS then performed oral sex on him.

Victim A disclosed another incident that occurred in a vehicle where MELISSA MARIE CURTIS kissed Victim A on the mouth.

Victim A disclosed another incident when MELISSA MARIE CURTIS had sexual intercourse twice with Victim A at her mother's residence located in Germantown, Montgomery County, Maryland inside a bedroom and in the living room.

Victim A further reported MELISSA MARIE CURTIS touched his penis with her feet while they were watching a movie at a theater in Montgomery County, Maryland.

Victim A reported MELISSA MARIE CURTIS provided him with alcohol and marijuana and encouraged him to perform oral sex on her which did occur.

Victim A further disclosed another incident when MELISSA MARIE CURTIS had sexual intercourse with him at his residence in Montgomery County, Maryland.

NOTICE OF ADVICE OF RIGHT TO COUNSEL FOR ALL JUDICIAL PROCEEDINGS

TO THE PERSON CHARGED:

- 1. This paper charges you with committing a crime.
- 2. If you have been arrested and remain in custody, you have the right to have a judicial officer decide whether you should be released from iail until your trial.
- 3. If you have been served with a citation or summons directing you to appear before a judicial officer for a preliminary inquiry at a date and time designated or within five (5) days of service if no time is designated, a judicial officer will advise you of your rights, the charges against you, and penalties. The preliminary inquiry will be cancelled if a lawyer has entered an appearance to represent you.
- 4. You have the right to have a lawyer.
- 5. A lawyer can be helpful to you by:
 - (A) explaining the charges in this paper;(B) telling you the possible penalties;

 - explaining any potential collateral consequences of a conviction, including immigration consequences;
 - (D) helping you at trial;
 - helping you protect your constitutional rights; and
 - (F) helping you to get a fair penalty if convicted.
- 6. Even if you plan to plead guilty, a lawyer can be helpful.
- 7. If you are eligible, the Public Defender or a court-appointed attorney will represent you at any initial appearance before a judicial officer and at any proceeding under Rule 4-216.2 to review an order of a District Court commissioner regarding pretrial release. If you want a lawyer for any further proceeding, including trial, but do not have the money to hire one, the Public Defender may provide a lawyer for you. To apply for Public Defender representation, contact a District Court commissioner.
- 8. If you want a lawyer but you cannot get one and the Public Defender will not provide one for you, contact the court clerk as soon as possible.
- 9. DO NOT WAIT UNTIL THE DATE OF YOUR TRIAL TO GET A LAWYER. If you do not have a lawyer before the trial date, you may have to go to trial without one.
