1. I, Michael Williams with the Scott County Sheriff's Office, having attended the Basic Law Enforcement Training and 30 years of law enforcement experience, knowing that false statements are punishable by law, make the following truthful statement:

2. I have probable cause to believe that between March 2023 and July 2023:

Name/Description: Kristin Rose Kirker

Committed the crime(s) of:

- Sexual Contact with a Student, a class E Felony, RSMO 566.086
- Sexual Contact with a Student, a class E Felony, RSMO 566.086

3. My probable cause is based on the following:

On the morning of Thursday, November 2, 2023 at approximately 0847 hours, I responded to [REDACTED] Benton, Scott County, Missouri in reference to a teacher/teacher aid having sexual intercourse with a student.

I met with Principal Winnberry, School Resource Officer Dodds and Victim 1's Step-parent. Victim 1's Step-parent explained to us, Victim 1 had told her on Wednesday, November 1, 2023 he had sex with a [REDACTED] teacher's aid, Ms. Kristin Kirker in his bedroom on [REDACTED] in Benton, Missouri. This took place at the end of last school year or the first of summer break 2023.

A SEMO NASV interview was set up for Victim 1. During the interview, Victim 1 disclosed during baseball season, suspect Ms. Kirker, asked for his phone number. They began exchanging texts, and over the course of time they began exchanging sexually explicit pictures, which included Ms. Kirker's breast and "booty" pictures. It also included naked pictures of Victim 1 exposing his penis. During the last school year, March to May 2023 Victim 1 went into her classroom, during that time the main teacher and students left to go somewhere. Victim 1 asked Ms. Kirker for a blow job, and she performed it on him. On another date, Ms. Kirker texted him to find out he was home alone, she came over and went to his bedroom. Ms. Kirker performed oral sex on him, he then laid in the bed and she climbed on top of Victim 1 and engaged in sexual intercourse (penis/vagina), at some point they changed positions where she was on bottom and he was on top. He was using a condom and did ejaculate, after sex she left.

After the disclosure, around 1440 hours, I had deputies respond to the school to escort Ms. Kristin Kirker to the Scott County Sheriff's office. She was brought to the sheriff's office by Captain Finley. At 1551 hours, I read Ms. Kirker of her rights under the Miranda decision. She advised she understood them and agreed to talk to me.

Ms. Kristin Kirker admitted that during the last school year (March to May) she and Victim 1 began texting, which lead to nude/partial nudes being exchanged between them. She admitted to performing oral sex on Victim 1 in her classroom near the kitchen cubicles. She admitted she went to his house, performed oral sex on him, which lead to them having sexual intercourse (penis/vagina) . She was not sure if that was during the school year or first of summer. She wrote out her own statement admitting to the details.

4. I believe it is possible the defendant may not appear in court in response to a criminal summons and/or that he/she may pose a danger to a victim, the community, or another person for the following reasons: nature of crime, she may be a flight risk.

5. I, Michael Williams, knowing that false statements are punishable by law, hereby state the above statement is true and correct to the best of my knowledge.
