3. The facts supporting this belief are as follows:

On 12/07/2023 I was contacted by Laquey SRO Brian York regarding a student who had come forward to report a sexual relationship between a student and a teacher. The teacher involved was identified as Hailey Carmack, AKA Hailey Clifton. I was able to speak to the confidential witness after obtaining permission from their guardian. According to the confidential witness they learned of the relationship after the confidential victim, a 16 year-old, showed them photographs of their back with scratches. The confidential victim advised the scratches were from Hailey after the confidential victim had sex with her in the confidential witness's driveway. The confidential witness also stated they over heard a phone call between the confidential victim and Hailey. During the phone call the confidential victim stated it was his birthday and Hailey replied from the other end I'm out of state but I can send you money baby.

During the interview the confidential witness stated Hailey is too friendly with student's and sometimes will dress inappropriately at school. When asked to describe what inappropriate was to them the confidential witness stated she will wear tight or low cut shirts to show off her "headlights" and will wear tight leggings that "show off her camel toe". The confidential witness also stated Hailey has openly discussed her personal life with the class and stated she has gotten in trouble with the administration for being "too close with students". information was verified by the Superintendent of Laquey Schools who stated she was spoken to about it. However, no other parties other than Hailey, the Principal, and Superintendent knew about the discussion.

The confidential witness also stated the confidential victim had told them he was the reason her divorce was pushed through and Hailey had wanted a divorce due to her husband only wanting to "do butt stuff". The school was able to tell me information provided by the confidential witness so far has been consistent in what he had reported to a teacher, Superintendent, and to myself when I spoke to the Superintendent after speaking to the confidential witness one on one in a private office at the school.

On 12/08/2023 I returned to Laquey Schools to make contact with Hailey and seize her phone via a search warrant. Hailey handed over her phone with no issues and did not have the normal behavior of someone facing the same accusations. Hailey denied having any kind of relationship with any students outside of school. I advised Hailey even if she spoke to students outside of the school there was nothing illegal about it, just a school policy violation. I spoke to her about the accusations and Hailey denied all of them and stated she has never had contact with the confidential victim outside of school. I thanked Hailey for her time and ended the interview.

I then applied for a search warrant for the contents on Hailey's phone. On 12/13/2023 I served Hailey with a copy of the search warrant and through the advice of her attorney, Charles Frahm, she would not provide a passcode for the phone. Hailey's phone was sent off to get into her phone and on 12/22/2023 I received an email with a PDF file from some of the content recovered from Hailey's phone. The messages recovered from Hailey's phone show a conversation between her and the confidential victim discussing their relationship.

On 12/23/2023 the Sheriff's Department received an anonymous tip that Hailey was leaving town to go to Texas and was going by to meet with the confidential victim before leaving town to go to Texas for the holidays.

On 01/03/2024 I met with confidential witness #2 in a recorded interview room. This following is a synopsis of the interview and the full interview will be included in the case file. Confidential witness #2 advised me she had been over to the confidential victim's residence and had spoken with his father. According to confidential witness #2 the confidential victim's father knew of the sexual relationship between Hailey and the victim as both had told him of their sexual relationship. The victim's father relayed to confidential witness #2 that Hailey and the victim have been in a sexual relationship and have used students as look outs while they had sex during school and that Hailey had been over to the residence before she left Missouri to go to Texas.

When confidential witness #2 advised the father they were going to come forward with the information he responded by telling her they are going to do it behind my back so I may as well let it happen. He also advised confidential witness #2 that he would lie for his son if he had to. After receiving this information, I went out and spoke to the father who did acknowledge that Hailey had been over at their residence before leaving to go to Texas.
