As sureties, were hereby jointly and severally certify that we have property valued over and above all debts and liabilities that has a fair market value equal to or greater than the amount of the above bond, and we, and each of us, waive the benefit of all laws exempting property from levy and sale under execution or other process for the collection of debt by the Constitution and laws of the State of Alabama, and we especially waive our rights to claim as exempt our wages or salary that we have under the laws of Alabama, and our rights to homestead exemptions that we have under the Constitution of Alabama and the laws of the State of Alabama, as set out in a separate writing.


STANDING ORDER

If you are released from custody (whether personal recognizance or otherwise), you must:


- 1) Appear to answer and submit to all orders and process of the Court having jurisdiction in the case.
- 2) Refrain from committing any criminal offense.
- 3) Not depart from the state of Alabama without the permission from the Court having jurisdiction of this case.
- 4) Promptly notify the Court of any changes of address or phone number.
- 5) Other conditions:

The provisions of this Release Order may be revoked or modified by the Court for cause. This Release Order and any appearance bond executed in compliance with it will continue in force and effect until the dismissal, acquittal, or conviction on the charges, unless sooner revoked or modified by the Court. Upon report of a violation of any of the above conditions, a warrant for your arrest will be issued.

I have read or have been advised of the matters herein set forth. I understand that failure to abide by these conditions may subject me to additional charges and the revocation of release.
