
The Affiant has personal knowledge of the matters set forth in this Affidavit and any attached Exhibits, and/or the information was imparted to me in the performance of my official duties as a law enforcement officer. Affiant has the required training and experience in these matters as follows:

Your Affiant, Amanda Baranowski, is employed by the City of Tampa Police Department, and as such is a law enforcement Officer with the State of Florida. Detective Amanda Baranowski has been employed by the City of Tampa Police Department since March 21st, 2011. Your Affiant has successfully completed a seven hundred seventy (770) hour Police Academy at Manatee Technical Institute operating under statutory authority and regulations of the Florida Department of Law Enforcement (FDLE) and Criminal Justice Standards and Training Commission (CJSTC). Your Affiant attended State College of Florida and Hillsborough Community College where she received her associate of arts degree. Your Affiant is currently assigned to the Tampa Police Department's Criminal Investigations Division, Special Victims Unit and is responsible for investigating sexual batteries, lewd offenses, child abuse/neglect and other various crimes against children and adults to include crimes of sexual cyberharassment and child pornography related offenses. Your Affiant is also responsible for emergency callouts assigned to her and following up as needed. Your Affiant has attended specialized training schools conducted by the Florida CJSTC. Your Affiant has in the past applied for and been granted search warrants within the iurisdiction of the Thirteenth Judicial Circuit, in and for Hillsborough County, Florida, which resulted in the seizure of evidence. Your Affiant has personal knowledge of the matters set forth in this affidavit and the information was imparted to your Affiant during the performance of her official duties as a law enforcement officer.

That the facts tending to establish the grounds for this application and the probable cause of Affiant believing that such facts exist are as follows:



Your affiant conducted research on the defendant and did not locate any information to corroborate her being a minor. Your affiant located information through the Department of Highway Safety and Motor Vehicles (DHSMV) which corroborated her being an adult (22 years old). Your affiant requested school records under the defendant's name which came back indicating the defendant was an adult. Your affiant obtained employment records for the defendant, which again showed information supporting her being an adult and not a minor. The employment records showed the defendant worked for Publix Supermarkets, which was also later corroborated by victim in statement about their relationship.

After obtaining information concerning the defendant's actual age, a follow-up interview was completed with victim on November 9th, 2023 concerning this investigation (2023-



On 11/13/2023, your affiant contacted the corporate office for Publix and confirmed the defendant was still an active employee with a hire date of 03/10/2023. I was advised the defendant was a part time bakery clerk.

On 11/15/2023, your affiant spoke with Publix Loss Prevention Associate T. Hester who advised the defendant worked for the Publix located at 10015 N Dale Mabry Hwy, Tampa, FL 33618.

Your affiant responded to the Publix located at 10015 N Dale Mabry Hwy, Tampa, FL 33618 and met with Assistant Manager M. Galindo and Bakery Manager Julie Whitley. I showed two photographs of the defendant to them, one provided by victim and still photo captured from Officer Feinman's body camera footage, and they independently identified the defendant as the person in the photographs and stated she was an adult (over 18 years of age).

Based on the foregoing totality of circumstances, the Affiant has reason to believe and does believe that there are currently items of evidence related to an active criminal investigation, to wit: specific technical data/information pertaining to the use of Snapchat (Snap Inc.) account(s) with the below associated user/identifying information:

The actual subscriber information seized will be listed on a return and inventory to be filed within this Judicial Circuit within ten days of execution of this warrant. However, the receipt of the physical data may take a significant time exceeding the ten days of execution of the warrant. For this reason, the "return" inventory will be satisfied by a list of the subscriber information being sought.
