(From this point on: this report is being written on Thursday 6/15/23, as the system went down for maintenance on Wednesday 6/14/23) Comm of Mass heading that underneath it said "Department of Children rind Families" Seeing this prompted them to investigate further. Admins contacted DCF to inquire if the social worker listed was in the office. The phone number on the letterhead was incorrect, and the cell phone listed went to voicemail. A call to the DCF office in Lowell (as that is the office that the letter came from) and was informed that no worked at that office. The person on the other end chekced to see which office she may be out of, and no was listed as a DCF employee. This prompted to contact 911 and the TS03. Also responding was the TS04 (Reyes). This is what started the series of events into this investigation. Additional and more detailed information will be documented on internal administrative report Form 26. Sgt. Det. Marc Sullivan of HTU was notified of this.
