On Saturday, December 9, 2023, at about 0836hrs, [REDACTED] called 9-1-1 to report that her father, Sony Josaphat had shot [REDACTED] and [REDACTED]

At about 0845hrs, Deputies from the Palm Beach County Sheriff's Office arrived at the home located at [REDACTED] unincorporated [REDACTED] and discovered [REDACTED] suffering from multiple gunshot wounds. Deputies pronounced them deceased at 0842hrs, and established a crime scene. [REDACTED] are lying on the sidewalk outside the front door. Deputies requested that [REDACTED] and anyone inside the home exit. [REDACTED] was home with her brother [REDACTED] during the incident. Deputies conducted a protective sweep of the residence and did not locate any additional persons.

Detectives from the Violent Crimes Division later arrived on the scene and conducted interviews with [REDACTED] who all live in the home. [REDACTED] was not home during the incident but provided detectives with valuable insight regarding [REDACTED] and [REDACTED] relationship. Based on the interviews, detectives learned that the suspect, Sony Josaphat, and [REDACTED] recently married [REDACTED]. Sony has not lived at the residence in over a year but randomly shows up from time to time and has a history of being controlling, and asking [REDACTED] probative questions about [REDACTED]

According to [REDACTED] has a friend who has told him to record [REDACTED] phone calls. This morning, [REDACTED] was outside of the home with [REDACTED] and [REDACTED] were installing exterior cameras at the home. [REDACTED] was getting groceries from the trunk of her car when she noticed [REDACTED] Sony Josaphat walking south through the yard on the east side of the home. [REDACTED] thought that this was odd because when Sony had come over in the past, he parked his vehicle in the driveway or the swale across the street. Sony asked [REDACTED] if [REDACTED] and [REDACTED] were home. [REDACTED] did not answer Sony, instead, she began walking towards the front door with groceries, Sony walking behind her. When she reached the front door, Sony greeted [REDACTED] and [REDACTED]. After a few moments, Sony pulled out a pistol and shot [REDACTED] and [REDACTED]. [REDACTED] said after they were both shot, Sony kept shooting [REDACTED] multiple times.


NARRATIVE CONTINUATION

Sony then fled the scene and drove to PBSO Headquarters in his vehicle. There, he entered the main detention center courthouse surrendered himself to deputies, and said that he had just killed [REDACTED] and [REDACTED]. Deputies detained Sony Josaphat and secured his gray Infiniti QX60 bearing FL tag 6488IP in the parking lot which contains the murder weapon.

Your Affiant conducted a post-Miranda video-recorded interview with Sony Josaphat. The following is a synopsis and not verbatim.

Sony and [REDACTED] were officially [REDACTED] on October 5, 2023. Since then, [REDACTED] has been disrespecting him and blocked his phone calls. He found out that on December 2, 2023 [REDACTED] Sony said this filled him with anger and he hasn't been able to sleep. On today's date he left his apartment at 1179 Benoist Farms Rd and traveled to [REDACTED] to take his daughter to breakfast. When he arrived he saw his [REDACTED] and [REDACTED] installing a surveillance camera by the front door. Sony said anger took over him. He put his full 17 round pistol magazine into his Glock 17 and chambered a bullet. He put the Glock in his front waistband and exited his vehicle. He walked up to [REDACTED] and said, "Good Morning." They said "Good morning" back to him. Sony then shot [REDACTED] in the upper torso and head. He then shot [REDACTED] several times. He said his daughter [REDACTED] witnessed the shooting. He then left in his vehicle and noticed his Glock magazine was empty. He called his Pastor [REDACTED] and told him he shot and killed [REDACTED]. Sony traveled to 3228 Gun Club Rd (HQ) where he told a deputy he killed [REDACTED]. Sony said he knew what he did was wrong and has never done anything like this. Sony said [REDACTED] were not armed with weapons during the shooting. Sony had purchased his Glock because he is currently in class 221 at the Palm Beach State College. Sony Josaphat's version of events match the evidence observed at [REDACTED].

Based upon the above investigation your Affiant believes Probable Cause exists that Sony Josaphat unjustifiably murdered [REDACTED] and [REDACTED] and did so from a premeditated design. This is a violation of Florida State Statute 782.04 (1)(a)(1).
