I, Sergeant Jacob Greer, with the Ouachita Parish Sheriff's Office, certify under oath based on the information outlined below, that there is probable cause to believe Tatum Hatch on or about 12/15/2023 at 0800 did commit:

Count(s) 1 of 14:81.3 Computer Aided Solicitation of a Minor (Felony)

within this State and Parish at:

613 Northwood Drive West Monroe, LA 71291
and the jurisdiction of the 4th Judicial District Court, contrary to the form of the statutes of the State of Louisiana in such case made and provided, and against the peace and dignity of the same, in that the following did occur:

On 12/15/2023 The Ouachita Parish Sheriff's Office was contacted by the West Monroe Police Department in reference to a student claiming to be in an inappropriate relationship with a teacher. I contacted the father of the 15-year old student, and he stated his son told him the relationship had been going on for a year and a half. The father then stated the victim showed him an Instagram message thread that supported his son's claims. The thread appeared to be from Tatum Hatch, a 32-year-old teacher at West Monroe High School.

I then met with the victim, and he opened his cell phone and allowed me to view the contents. I observed an Instagram message thread that had been screen-recorded on the phone. The messages from Hatch detailed the fact that she wanted the victim to "know she wanted him to fuck her". Later in the message thread, Hatch describes to the victim that he will come in through her bedroom window. She then asks him if he will be rough or gentle with her. The victim responds by asking her what she wants. Hatch then replies that she doesn't know, but she has thought about it. She then asks the victim if he is going to take her clothes off and is she going to take his off. The victim states he is scared, and Hatch also says she will be too. She states she is worried the victim will find someone else to be his "first".

There are other conversations over several months. One of these conversations takes place at a recent after-hours school function. Hatch is trying to get the victim to come sit with her, and she is descriptive about where she is sitting. According to the principal at West Monroe, Hatch was sitting where the messages said she was. Other messages from Hatch talk about her not getting into as much trouble if the victim comes to her house rather than her visiting his house. The victim stated Hatch has sent nude selfies to him through the message thread; however, all of the messages were done in Vanish Mode. This meant the threads were no longer on the phone. The victim also stated Hatch has come to his residence about a year ago. He stated it was late at night and she met him at the end of his driveway. He stated Hatch rubbed his penis, but they did not have sex. He stated Hatch had her infant child in the vehicle when she came to his house.

I conducted a post-Miranda interview with Hatch on 12/16/2023. In that interview, she admitted to talking to the victim through Instagram Messenger. She was worried if she admitted to certain questions about what she had sent the victim that she would lose her children and chose not to answer those questions. She did admit she had given the \$500-\$600 over the past year. She stated she was afraid of the victim because of a rumor she had heard about him, and that is why she gave him money.

Search warrants were sent to Instagram that led to the recovery of part of the messages. Those parts lined up with the screen record provided by the victim, and showed the messages did come from Hatch's account. I also recovered a nude photo of Hatch on the victim's phone after a forensic download was completed.

Your affiant request an arrest warrant for Tatum hatch for 1 count of Computer Aided Solicitation of a Minor.
