## **Incident # 240127-0008**

WARD, MICHAEL

On 01/27/2024 at approximately 0708 hours I was dispatched to 3597 Sweethome Rd. in reference to a domestic violence incident. While en route, dispatch advised that the complainant's father, who is special forces in the military, physically attacked her and her mother. Dispatch advised that the father has a history of narcotics and alcohol use and that he was running around outside in his underwear. Dispatch advised that the father tried to stab the complainant's mother and that he no longer has knife and that he hit her mother in the head with a frying pan. While en route, dispatch advised that the father called advising that he was at 3596 Sweethome Rd. and that his wife and daughter hit him in the head with a frying pan and he ran away from them.

Due to the information received from dispatch, it appear the father at 3596 Sweethome Rd. was possibly the suspect and aggressor. Deputy A. Simon #928 arrived on scene first and went to 3596 Sweethome Rd. to make contact with the male first. Upon my arrival, I observed a white male at 3596 Sweethome Rd. sitting on the front porch with blood all over the front of his body coming from his head. I grabbed medical supplies and made contact. I observed a large and deep gash in the top of his head that was still actively bleeding. I rendered medical attention by applying pressure to the wound and wrapping the wound with gauze to stop/slow the bleeding. During this time, Deputy A. Simon #928 went to 3597 Sweethome Rd. to make contact with the original complainant. While I was rendering aid, the male advised his name was David Davis DOB 08/25/1964 and that last night, 01/26/2024, he told his wife that he

wanted a divorce and they got into a big argument. David advised that he went to sleep last night and then this morning while he was sleeping, was struck very hard in his head forcing him awake. David advised he immediately began defending himself and noticed that his wife was hitting him in the head with a frying pan. David advised he was able to get away from them and ran to his neighbor house, 3596 Sweethome Rd., and called 911 from there.

While I was rendering aid to David, Deputy A. Simon #928 advised via radio that he had two more victims and a lot of blood at 3597 Sweethome Rd. EMS arrived and I advised that the severity of the victims at 3597 was unknown to me but David had suffered what appeared to be a severe head injury. I assisted EMS with getting David on the gurney and into the EMS truck. I grabbed more medical supplies from my patrol vehicle and went across the road to 3597 Sweethome Rd. Upon entering the front door into what appeared to be the living room, I observed two females on the floor. One female, who identified herself as Kelly Davis 02/19/1994, was sitting upright in the middle of the living room floor, and the other female was sitting upright in the entry way of the living room and kitchen, was directly across from the front door to the residence. It appeared that Kelly had more and the worse injuries after observing several lacerations to the body and neck of Kelly. I immediately began rendering aid to Kelly. Upon further observation, every laceration found on Kelly was superficial/shallow lacerations, even the laceration of her neck. I still applied bandages and gauze to ensure the bleeding stopped. While rendering aid to Kelly, EMS was rendering aid to the other female, who was barely able to identify herself as Pam Davis DOB 11/15/1962

but advised that she was 62 year old and was not able to advised her birth year. Dispatch was able to find a driver's license for Pam and I identified her as Pamela Davis DOB 11/15/1961. While rendering aid, I requested Cpl. C. Erb #927 to take pictures of the scene before more personnel arrived. I was unable to obtain a complete verbal statement from Kelly while on scene due to being focused on rendering aid and securing the scene. I was unable to obtain a verbal statement from Pamela while on scene due to Pamela being in and out of consciousness and unable to completely answer questions. Cpl. C. Erb #927 notified LT. B. Holt #904 who did respond and arrived on scene.

Kelly did advise while on scene that her father was David and that he attacked her and her mother Pamela with a frying pan and a knife which started in David's bedroom. Kelly advised that she was able to escape by running out of the back door but knew that David followed her but was unsure of where he went.

David Davis was transported by EMS to Skyline Medical Center Nashville for treatment. Pamela Davis was transported by EMS to Skyline Medical Center Nashville for treatment. Kelly Davis was transported by EMS to Centennial Ashland City (CAC) for treatment. I briefed LT. B. Holt #904, who advised CID would work it and instructed me to go to CAC and obtain a statement from Kelly. LT. B. Holt #904 instructed me to obtain a verbal statement and I would complete a written statement for Kelly.

I arrived at CAC and made contact with Kelly in Emergency Room #5. Kelly gave me permission to obtain good and clear pictures of all of

her wounds from this incident which appeared to be approximately 13 superficial lacerations from her neck to her front torso and her lower back. While speaking to Kelly, she did give me permission to complete her written statement as she gave a verbal statement.

Kelly advised that she has never known her father, David, to be anything other than controlling and abusive to both her mother, Pamela, and herself. Her earliest memory is of David hitting Pamela due to them arguing about her cheating on David. Kelly advised that her and Pamela have been abused and controlled by David all of her life. David has rules that Kelly and Pamela have to look a certain way, weigh a certain amount, while he is at work they have to complete chores around the house but cannot be doing chores when he gets home from work, they cannot watch TV when he is home, cannot use their phones while he is around, and that if they break any of these rules he has a episode that she called Drill Sergeant Mode where he stands up straighter, puffs his chest out, and yells as loud as he can, and most of the time shoving her and Pamela. Kelly advised that for the past few weeks, David has been telling Pamela that he wants Pamela dead and that it was going to happen one way or another. Kelly advised that last night, 01/26/2024, at around 2100 while she was sitting on the couch in the living where she sleeps, David seemed out of it and was swaying back and forth like he was falling asleep while standing in the kitchen. Kelly advised that after about 20 minutes of this, David walked to his bedroom, which is at the end of a hallway to the right of the living room, using the wall as a crutch to walk. Kelly advised that she took a shower and went to sleep around 2230 and knew that Pamela was in her room at the end of the hallway to

the left with the door partially open just enough to allow the cats to come in and out. Kelly advised that at around 2300 David came out of his room very energetic and smacked Pamela's door open hard enough to make it bounce off the wall and start to close, yelled "you are a stupid lazy ass bitch and then went to the kitchen and began hitting chips. Pamela came out of her room and into the kitchen and confronted David asking what that was about. David advised that he was informing her of the obvious and that he did it because he has a dumb ass wife. Kelly could not see this altercation but heard them arguing and David in his drill sergeant mode when eventually he heard David stomping across the kitchen and then heard what sounded like Pamela falling. Kelly advised he went into the kitchen and told David he does not get to do that to Pamela. Kelly advised David got into her face and began yelling at her and shoved her, then they began shoving each other until eventually Kelly stopped and sat down on the couch. Kelly advised that this ended on 01/27/2024 at approximately 0330 with her going to sleep on the couch, Pamela going back to her room, and David going to his room. Kelly advised that around 0600 she woke up and began watching a show on her phone when David suddenly slung his door open and stood in his door way. She got up and stood at the entrance of the hallway and living room and Pamela stood at her doorway. Kelly advised that David was screaming "I don't want to hurt you" repeatedly and observed a knife in his left hand and began walking towards her with a quickened pace. Kelly advised she turned around to walked further into the living room when David grabbed her hair and forcefully escorted her into his room and pushed her onto the bed. Kelly advised she tried to crawl across the bed and get away but David grabbed and eventually climbed on top of Kelly on top of the bed and



pinned her down. Kelly tried to push and crawl out from under David while trying to hold his hand with the knife down. Kelly advised that she was hanging partially on the bed with David pulling her arm, Pamela came into the room with a frying pan and demanded David to let go. Kelly advised that he did not let go and Pamela hit David on the head 3 times with the frying pan when David pulled her further onto the bed and rolled over on top of her. Up to this point, Kelly advised he had only been using his right hand that did not have a knife and now began using his left hand that was still holding a knife. Kelly advised that he took his left hand and knife and pushed down into her stomach with his body weight while using his right hand trying to push Pamela away. Kelly advised that he kept his left hand and knife on her stomach and laid across her body with him still pushing into her stomach with the knife still in his hand when she noticed Pamela sitting on the floor. Kelly advised she was able to crawl out from under David when David rolled onto his back and pulled her arm up between his legs with both his legs across her torso and neck and began to choke her. Kelly described this as a MMA move and I recognize it to possibly be an arm bar. Kelly advised she could not breathe but did not lose consciousness. Kelly advised that she used her free right arm and grabbed his genitals as hard as she could which caused him to let go. Kelly advised she got up and ran out of the room, down the hallway, into the living room and to the right into the kitchen, to the right back wall down the stairs into the basement. Kelly advised she got into the basement and hesitated to hide in the basement or run out of the house. Kelly eventually decided to run and that due to her hesitation, David caught up to her, and while she was running through the basement into the garage where the back exterior door is, she heard David close behind

and turned to him. Kelly advised she observed Pamela try to get between him and her and David turned and shoved her into his ammo cans and dropped the knife and continued after her. Kelly ran out of the door and to the left and that when they got into view of the road, he turned and ran away from her around the opposite side of the house. Kelly advised she did not know where he went and that she ran back inside, grabbed the knife, and assisted Pamela back upstairs and left her standing where we found her. Kelly advised she closed and locked the front door and went to David's room to see if they could barricade themselves in his room and but knew she could not get Pamela down the hallway. Kelly advised she saw the frying pan laying on the floor in the hallway but at some point after locking the front door and going to David's room, she lost the knife.

While on scene, I observed a frying pan sitting on the floor in the hallway in front of both David and Pamela's door with a knife that I observed to have serrations like a steak knife. Kelly described the knife and identified the knife as the knife David uses when he goes hunting.

I was not able to get the phone numbers for David or Pamela. Lethality screen completed for Kelly Davis, she did screen in but refused to speak to Safe Haven. Phone number to Safe Haven left with Kelly.
