NARRATIVE The undersigned certifies and swears that there is probable cause to believe the above-named defendant.
 on the 21 day of January, 2023, at approximately 1135 a.m. a.m. p.m.
 at 301 Memorial Medical Pkwy DAYTONA BEACH within Volusia County, violated the law and did then and there:

1 On January 21, 2023 at approximately 1135 hours, Daytona Beach Police units responded to Advent Hospital (301 Memorial Medical Parkway) in
 2 reference to a shooting. While on scene units responded to the 11th floor. Officers contacted several witnesses who stated there was a woman inside
 3 of room 1106 with a firearm and that they heard at least one gunshot coming from the room. NOTE: All witnesses are known to law enforcement
 4 however, their personal identifying information will be withheld from this report pursuant to Florida law.
 5
 6 Det C Howell arrived on scene and contacted a witness (W1) who advised that they had relevant information to provide in reference to this incident.
 7 Det Howell interviewed W1 who advised the following: W1 was informed of the gunshot coming from room 1106. W1 and W2 entered room 1106 and
 8 observed the defendant seated on the left side of the patient's bed. The defendant was seated with her back to the far wall and the patient bed
 9 between her and the entryway of the room. W1 observed the defendant holding a black revolver handgun which she had aimed at W1 and W2. W1
 10 observed the victim laying unresponsive on the bed in a pool of blood. The defendant then informed W1 and W2 that she had a gun and demanded
 11 that W1 and W2 exit the room. W1 and W2 then back out of the room and began clearing the immediate area of hospital staff. W1 stated that W1
 12 never lost visual contact of room 1106 and advised that no one entered or exited the room until law enforcement arrived on scene.

 14 Det Howell interviewed W2 whose statement was consistent with W1's. However, W2 advised that W2 was unable to see into the room because the
 15 privacy curtain partially blocked W2's view. Both W1 and W2 stated that they could smell burnt gunpowder as they entered the room. W1 and W2
